

## Marsy's Law Protects and Serves Crime Victims in California

Marsy's Law gives important rights to crime victims who were hurt physically, emotionally, or financially because of a crime (or attempted crime).

To qualify as a victim of crime under Marsy's Law, you must be the:

- Direct victim,
- Close family member,\*
- Guardian, or
- Your legal representative.

*\*Close family members include: spouse, parents, children, brothers and sisters*

## Victim/Witness Assistance Centers

---

The Victim/Witness Assistance Centers help victims get services, ask for compensation, and understand their rights. Your Center can also guide you through the criminal justice system.

### The Centers can help you in many ways. Right after the crime, they will:

- Make sure you are offered counseling, emotional support, and information about the court process
- Help you get emergency housing, food, and clothing, if you need it

### Later they will:

- Connect you with the resources and referrals you need
- Go with you to court and court-related appointments
- Help you apply for reimbursement for expenses related to the crime

### They will also:

- Help you ask for a restraining order if you need protection
- Make sure you are notified about each step of the criminal justice process, and
- Help you prepare for each step of the process.

## Your Victim/Witness Center will tell you more about these other programs:

### California Victim Compensation Program (CalVCP)

CalVCP can reimburse you for expenses caused by the crime (except expenses covered by insurance or other programs).

### California Dept. of Corrections and Rehabilitation

If the offender was sentenced to the California Dept. of Corrections and Rehabilitation, you have the right to:

- Get money (restitution) to pay for your losses
- Be told about the offender's status and any parole hearings
- Ask the Board of Parole Hearings to order special parole conditions
